# **Position**

On holding in the hero-city of Moscow from June 26<sup>th</sup> to July 4<sup>th</sup>, 2022. The third Eurasian club football tournament, among youth football team born in 2007 PFC. FC of Cities - Heroes, Cities of Military Glory of Russia, CIS. EAEU and SCO for the Eurasia and CIS Cup, dedicated to the 77<sup>th</sup> anniversary of the Victory of the Soviet people in the Great Patriotic War of 1941-1945.

## 1. GOALS AND OBJECTIVES

The competition is held for the purposes and in accordance with paragraph 3 of part 4 of Art. 26.2 329-F3 "On physical culture and sports in the Russian Federation" this Regulation

prohibits unlawful influence on the results of sports competitions.

- Popularization and development of children's and youth football in the city of Moscow, CIS and SCO countries;
- Identification of the winners of the Tournament and the best football players of the Tournament;
  - Strengthening international sports ties, the CIS and SCO countries;
  - Mass attraction of Moscow residents to systematic physical education and sports;
  - Leisure organizations for football fans.

#### DATE AND VENUE

The tournament is held from June 26<sup>th</sup> to July 4<sup>th</sup>, 202 for 2 years in the city of Moscow. JSC "Luzhniki" FC FShM st. Luzhniki, 24, bldg. 6.

Arrival day June 25th, departure day July 4th, 2022

June 27,28,29, 2022 games in subgroups from 10:00 to 14:00.

July 1st - games of the semi-finals.

On July  $2^{nd}$ , the game for the  $3^{rd}$  place from 10:00 to 11:30.

July 3<sup>rd</sup> final from 12:00 to 13:00.

Rewarding from 13:30 to 14:00.

# 3. ORGANIZATION AND MANAGEMENT

The general management of the preparation and conduct of the tournament is entrusted to the Organizing Committee, which approves the main panel of judges (hereinafter - GSK), from among the judges of the Moscow panel of judges of the Regional public organization of the Moscow Football Federation.

Order on state accreditation No. 356 of 12/30/2016 ROO "Moscow Football Federation" No. 25-9 / 166 of 04/06/2017, main state registration number 1037739164957.

#### 4. PARTICIPANTS OF THE TOURNAMENT

The tournament is held in accordance with this approved procedure.

The tournament is attended by 16 teams, which include players born in 2007 and older. The composition of the team is 20 people, including 18 football players and 2 coaches.

## 5. ADMISSION OF TOURNAMENT PARTICIPANTS

Athletes from 15 to 16 years old (born in 2007) are allowed to participate in the Competition. Athletes are allowed to participate in the Competition who have a sports category not lower than the first in accordance with the Unified All-Russian Sports Classification (hereinafter - ESCC). Each participant of the Competition must have a medical clearance in the record book and on the official application.

Each participant, coach and delegation representative must comply with the requirements for the prohibition of the use of doping agents and methods in accordance with the order of the Ministry of Sports dated August 9, 2016. No. 947 "On Approval of the All-Russian Anti-Doping Rules", and the requirements of the World Anti-Doping Agency.

The admission of the Tournament Participants (footballers and team officials) is carried out on the basis of the application and the decision of the credentials committee. The meeting of the credentials committee is held on the day of arrival of the teams.

Teams form their applications for participation in the Tournament. The application must be signed by the coach and the team doctor.

Participants of the Tournament must, by June 10<sup>th</sup>, 2022, send applications and consent to the processing of personal data to the Organizing Committee of the Tournament. Changes to the submitted application are possible until June 20<sup>th</sup>, 2022 (the application form is attached).

By June 10, 2022, the national associations (football federations), the heads of the football teams must submit electronically to the address: <a href="mailto:orgcom@eurasialeague.ru">orgcom@eurasialeague.ru</a> the following official information about the team:

- Team photography;
- 3x4 color photographs of team leaders, players with the surname, name,

patronymic;

- Information about the club: history of the club, achievements;
- The team's entry list in Russian and English, drawn up in strict accordance with the procedure (the spelling and stress of the names and surnames of the players must be verified in the entry sheet);

The commission is held on June 15<sup>th</sup>, 2022. or the day before the start of the competition, at the address: Moscow, st. FC FShM Luzhniki 24, building 6.

List of documents for participation in the tournament:

- Passport (birth certificate for minors) or a document replacing it;
- Agreement (original) or a personal certificate to the collective agreement (original) on life and health insurance against accidents, damage;
  - Compulsory health insurance policy;
  - Additionally, it is prescribed independently.

• Samples of team equipment. (2 sets of uniforms for field players: leggings, underpants, jersey, as well as two goalkeeper sets). During the period of the Tournament, each player must be assigned a permanent game number specified in the application. When holding the credentials committee, the team official must check the flag, anthem, and the team logo with the representative of the credentials committee.

Without the provision of the above documents, a team is not allowed to participate in the Tournament.

## 6. FORMAT AND CONDITIONS OF THE TOURNAMENT

The matches of the Tournament are played according to the Laws of the Game of Football, approved by the International Council of Football Associations (TFAB) June 2019, as well as taking into account the requirements of this procedure.

The draw for the teams participating in the Tournament is held by GSK no later than May 20, 2022. The format of the tournament is 11x11. The tournament is held in two stages: the group

stage and the playoffs.

Preliminary stage: the teams are drawn by lot into two groups of four teams, which in a single round-robin tournament determine the participants in the final stage - two teams from each group. The 2nd final stage is played according to the principle 1 A -2B, 2 A -1B. If the match ended in a draw in regulation time, the series immediately breaks through from the 11-meter mark according to the rules of the game. In the case of a draw here, too, strikes are made from the 11-meter mark by one player of each team to the result. Substitutions: An unlimited number of substitutions are allowed during a match. Yellow cards received at the 1st stage are excluded in the final stage. Red cards in accordance with the Regulations are retained.

Final stage: final.

The final e meets:

1st group winner - 2nd group winner

The runners-up teams in their groups play for 3rd place.

At the preliminary stage of the competition, the duration of the game is two halves of 30 minutes.

At the final stage - two halves of 30 minutes each. Break for 10 minutes. Substitutions: in the final stage of substitutions, the same as in subgroups. 11 + 7. During the match, 7 substitutions are allowed without the right to reverse substitution.

The tournament is held at the stadium in Moscow: JSC Luzhniki (Luzhniki st., 24). Team representatives 40 minutes before the start of the match enter the names and names of the players in the match report, indicating their numbers. The team that hosts the field according to the calendar fills in the match report first.

The appointment of referees for the matches is carried out by the Organizing Committee. The chief referee of the match must, before the start of the game, together with representatives of the meeting teams, determine the colors of the uniform (shirts, shorts, leggings and goalkeeper's uniform) in such a way as to exclude their coincidence. If the colors match, the team named second in the tournament calendar will change its uniform.

After the end of the game, the representatives of the teams and the chief referee of the match are obliged to draw up the protocol of the game within 10 minutes. If during the game there were warnings, sending-offs and injuries of football players, as well as violations of order

at the stadium, then the chief referee of the match must make an exhaustive record of this in the protocol before it is signed by the team representatives.

Protests against the referee's decision made on the field based on facts that took place in the game are not accepted. Football players and team leaders participating in the tournament must comply with all the requirements of the Laws of the Game and these Regulations. Team leaders do not have the right to interfere with the actions of the match referees, they are fully responsible for the behavior of their team's players.

If the game was stopped due to the unruly behavior of the players of one of the teams, then this team is credited with a defeat with a score of 0-3, and the opposing team is awarded a victory with a score of 3-0. In the event of a greater goal difference, the result of the match remains valid.

If the game is not over due to the fault of both teams, then they will be considered defeated with a score of 0-3.

During the tournament, the following disciplinary sanctions will be imposed on players:

If removed from the field:

- for two warnings in one game skipping one game
- for "foul of last resort" skipping one game;

For other disciplinary sanctions related to the removal of players, the decision is made by the Organizing Committee. The refereeing of the tournament is carried out by the judges of the Moscow Collegium of Judges of the RPO "Moscow Football Federation" and the Russian Football Union.

Refereeing is carried out in accordance with the current Laws of the Game of Football (3rd March 2017 edition). All footballers must wear shin guards and have a neat appearance. The player's number on the jersey must correspond to the number under which this player is recorded in the application.

Team coaches must enter the names of the players in the protocol 4.5 minutes before the start of the match. The names and surnames of 18 football players (11 main and 7 substitutes) and 2 official representatives of the teams are entered into the match report. In each match, it is allowed to replace 7 players from the number of substitutes included in the match report. The team named first according to the calendar - the nominal hostess of the field, fills in

the match report first.

Warm-up of substitute players is allowed only in the area defined by the match referee.

Places of teams are determined by the highest sum of points scored in all matches (victory - 3 points, draw - 1 point, defeat - 0 points).

In the subgroup, in case of equality of points, 2 or more teams have. Add the smallest number of conceded balls among themselves further in the subgroup. The smallest number of penalty points received for violation of the Laws of the Game yellow card 1 point, red card 5 points. In case of equality of points for two or more teams following the results of the group stage matches, the advantage is given to the team that has:

Most wins in all matches in a group;

- The best result in the match between the compared teams (in order the number of points, the number of wins, the best difference between goals scored and conceded, more goals scored, the least conceded goals.);
  - The best difference between goals scored and conceded in all matches;
  - Most goals scored in all matches;
  - Fewest conceded goals in all group matches;
- Least number of penalty points received for violation of the Laws of the Game
   (yellow card -1 point, red card-5 points);

In case of equality of all indicators by lot.

#### 7. RESPONSIBILITY OF FOOTBALL PLAYERS AND TEAM LEADERS

Football players and heads of teams participating in the tournament must comply with all the requirements and norms of these Regulations, while showing high discipline, respect for opponents, referees and spectators. The team leaders have no right to interfere with the actions of the match officials. In addition, they are responsible to the Organizing Committee for the conduct of their team's players. If the game was stopped due to the unruly behavior of the players of one of the teams, then this team is considered defeated.

## 8. REFEREEING AND INSPECTION OF MATCHES

The refereeing of the tournament matches is carried out in accordance with the Rules of the Game. The appointment of referees for the matches is made by the Moscow Collegium of Referees of the ROO of the Moscow Football Federation. The match referee, together with the team leaders, is responsible for observing the rules for admitting football players to the game. The match referee is obliged to:

- Inspect the football field in advance, assess its quality and suitability for the match.
- 1 hour before the start of the match, provide the team representatives with the match report to enter the names and surnames of the players, as well as compare the colors of the uniforms of the field players and the goalkeepers of the teams in order to exclude their coincidence.
- Draw up the match report within 15 minutes after its end. If during the match there were warnings, sending-offs and injuries of football players, as well as violations of order at the stadium, the match referee is obliged to make an exhaustive record of this in the protocol before it is signed by the team representatives.

The Moscow Collegium of Judges of the ROO of the Moscow Football Federation considers official protests (with the exception of protests against the decisions of the referee made on the field on the fact that took place in the match) submitted only within 45 minutes after the end of the match. Protests are considered only if they are submitted in simple written form to the Moscow Collegium of Judges of the ROO of the Moscow Football Federation.

Heads and other team officials have no right to interfere with the actions of the match referees, they are fully responsible for the behavior of their team's players.

Teams' requests to replace the referees assigned to the match will not be accepted.

The Organizing Committee ensures that the Tournament has the equipment necessary for the referee, assistant referees and reserve referee for the proper performance of their duties.

The final protocols of the Competition are provided by the Chief Secretary of the Competition in paper and electronic form within 3 days from the end of the Competition in Moskomsport.

## 9. DISCIPLINARY SANCTIONS

For violations committed before, during and after the end of the game, the following disciplinary sanctions are applied to national teams, football players and officials of the Moscow Collegium of Judges of the ROO of the Moscow Football Federation:

- Warnings;
- Disqualification.
- I f the match is abandoned due to the undisciplined behavior of the players of one of the teams, this team is awarded a technical defeat with a score of 0: 3, and the opposing team is awarded a victory with a score of 3: 0. In the event of a greater goal difference, the result of the match remains valid.

If an undeclared or disqualified footballer participates in a match, the team for which he is playing is awarded a technical defeat with a score of 0: 3, and the opposing team is awarded a victory with a score of 3: 0. If the match is not finished due to the fault of both teams, they will be counted for technical defeats with a score of 0: 3.

When a team is awarded a technical victory (3: 0), the goals scored by the players of this team in the played match (s), the result (s) of which was (s) then (s) was (s) canceled (s), are not taken into account in their individual standings.

In relation to football players during the Tournament, disqualification is applied for misdemeanors committed during the matches:

- For every three yellow cards (warnings) received in different matches of the Tournament a disqualification for one match.
- For two yellow cards received in one game disqualification for one match (previously received warnings are not canceled);
- For a red card presented for depriving a player of the opposing team of an obvious opportunity to score a goal disqualification for one match.

For all disciplinary violations, including the removal of a player from the field for other reasons, the decision on disciplinary sanctions is made by the GSK.

The organizers and sponsors of the Competition may establish additional prizes for the winners and prizewinners of the Competition.

# 10.REWARDING TOURNAMENT PARTICIPANTS

The winning team of the Tournament is awarded the Cup, and each player of the team is awarded a medal. Prize-winning teams are awarded with memorable prizes, football players - with medals. Prizes are awarded to the following categories of Tournament participants, determined by the Organizing Committee: "best player", "top scorer", "best striker", "best midfielder", "best defender", "best goalkeeper0," youngest participant "," Audience Award " ".

The organizing committee has the right to decide on the presentation of other (unofficial team and individual prizes).

Teams are awarded by the Organizing Committee.

The organizers and sponsors of the Competition may establish additional prizes for the winners and prize-winners of the Competition.

# 11. FINANCIAL CONDITIONS OF PARTICIPATION IN THE TOURNAMENT

Sending participants (travel to the competition site and back, daily allowance, accommodation and meals) at the expense of sending organizations.

Financing of the costs of the competition is carried out at the expense of extra-budgetary and budgetary funds. The work of the judging team will be provided at the expense of extra-budgetary and budgetary funds.

## 12. ENSURING THE SAFETY OF THE TOURNAMENT

Competitions are held at sports facilities that meet the requirements of the relevant regulatory legal acts in force on the territory of the Russian Federation and aimed at ensuring public order and the safety of participants and spectators, if there are acts of readiness of the sports facility to host sports events, approved in the prescribed manner.

The owners (users) of sports facilities ensure public order and public safety: it is necessary to have a video surveillance system and technical equipment in accordance with the safety rules during official sports competitions for organizing access and inside the facility regime.

Ensuring the safety of participants and spectators of the Competition is carried out in accordance with the following regulatory legal acts:

- Temporary regulations on the procedure for organizing and conducting mass cultural, educational, theatrical, entertainment, sports and advertising events in Moscow, approved by the order of the Mayor of Moscow dated October 5, 2000. No. 1054-RM;
- By order of Moskomsport dated August 8, 2003 No. No. 627-a "On strengthening public safety in institutions subordinate to the Moscow Sports Committee";
- Decree of the Government of the Russian Federation of April 18, 2014 No. 353 "On approval of the Rules for ensuring safety during official sports competitions";

- Order of the Ministry of Health of Russia dated March 1, 2016 No. 134 "On the Procedure for organizing the provision of medical care to persons engaged in physical culture and sports (including in the preparation and conduct of physical culture events and sports events), including the procedure for medical examination of persons wishing to undergo sports training, to engage in physical culture and sports in organizations and (or) fulfill the standards of tests (tests) of the All-Russian physical culture and sports complex "Ready for work and defense";
- Other administrative documents on public safety issues during sports competitions in force at the time of the Competition.

The venue of the Competition meets the requirements of the relevant regulatory legal acts in force on the territory of the Russian Federation and aimed at ensuring public order and safety of participants and spectators, and has a passport of the sports facility's readiness for holding events.

#### 13. ANTI-DOPING SECURITY

The Ministry of Sports of the Russian Federation informs that on May 12, 2019, the amendments to the Code of Administrative Offenses of the Russian Federation (hereinafter referred to as the Code) entered into force. Federal law sets out in a new edition of Article 6.18 of the Code, which provides for administrative liability for violation of the requirements established by the legislation on physical culture and sports to prevent and combat doping in sports.

#### 14. INSURANCE OF PARTICIPANTS

The insurance company, insurance brokers and consultants are ready to organize a tender among insurance companies according to the drawn up and approved terms of reference in accordance with generally accepted international practices.

# 15. UNEXPECTED CIRCUMSTANCES

On all issues not provided for by this Procedure, including force majeure, decisions are made jointly by the Organizing Committee and the SSC. Such decisions are final and not subject to appeal.

When organizing the Tournament, organizers and leaders of youth football teams must comply with the requirements of the Regulations for the organization and conduct of official physical culture and sports events in the Russian Federation while the risks of the spread of COVID -19 (hereinafter - the Regulations) remain, approved by the Ministry of Sports of the Russian Federation and Rospotrebnadzor dated July 19 2020 and additions and changes to the Regulations approved by the Ministry of Sports of the Russian Federation and Rospotrebnadzor dated August 19, 2020.
